

#### COMMUNITY GOVERNMENT OF WEKWEETI BYLAW # 2019-11-17-00.6

# BY LAW NUMBER 2019-11-17-006 WILL BE 006

A bylaw of the Municipal Corporation of the Community Government of Wekweeti in the Northwest Territories to adopt items for the purpose of corporate identification to the provisions of the Tlicho Community Government Act, S.N.W.T., 2004, c.7. Sections 51. 70 and 72.

As the Community Government of Wekweeti desires to adopt and regulate the use of a municipal crest and or flag and or seal for the municipal corporation:

NOW, THEREFORE, THE COUNCIL OF THE COMMUNITY GOVERNMENT OF WEKWEETI, at a duly assembled meeting, enacts as follows:

# **SHORT TITLE**

1. This bylaw may be cited as the "Corporate Identification By-law"

### **GENERAL PROVISIONS**

- 2. The designs depicted in Schedule A, attached to and forming part of this bylaw, are adopted as the community government crest, flag and of the Tlicho Community Government of Wekweeti.
- 3. No persons other than officers authorized by the Community Government of Wekweeti shall use the corporate seal of the Community Government for any purpose.
- 4. A). No person shall without the authorization of the Community Government of Wekweeti shall:
  - B). use the community government crest or flag adopted under this bylaw for any purpose without the consent of the Community Government, or:
  - C). Sell or otherwise dispose of any item for profit containing the community crest and or flag without having first obtained from the Community Government a permit to do so, in the form shown in Schedule B, attached to and forming part of this bylaw, on such terms and condition as the council determine.
- 5. The Senior Administrative Officer is responsible for maintaining custody of the corporate seal and shall cause it to be affixed to any documents where required.
