# WEKWEÈTÌ COMMUNITY GOVERNMENT BY-LAW #002/05

BEING A BY-LAW OF THE COMMUNITY GOVERNMENT OF WEKWEÈTÎ, A TLICHO COMMUNITY GOVERNMENT IN THE NORTHWEST TERRITORIES, TO PROVIDE FOR THE PAYMENT OF AN INDEMNITY AND ALLOWANCE FOR EXPENSES TO MEMBERS OF THE COMMUNITY GOVERNMENT COUNCIL

WHEREAS the Tlicho Community Government Act, S.N.W.T. 2004, c.7, s. 98 requires that Council make rules governing indemnity and allowance for expenses to Members of Council.

NOW THEREFORE BE IT RESOLVED that the Community Government Council of Wekweeti in session duly assembled enacts as follows:

#### SHORT TITLE:

1. This bylaw may be cited as the Council Indemnity By-Law.

#### **DEFINITIONS:**

- "Chief" means the Chief of the Community Government of Wekweeti and sworn to hold office;
- "Committee Meeting" means a meeting of any committee established by the current Council;
- "Council" means the Council of the Community Government of Wekweetl and sworn to hold office:
- "Councillor" means a member of Council, other than the Chief and sworn to hold office;
- "Community Government" means the Community Government of Wekweetl established under s. 7 of the Tlicho Community Covernment Act;
- "Meeting" means a regular, special or emergency meeting of Council;
- "Member" means a member of Council;
- "Month" means a calendar month;
- "Schedule" means a schedule attached to and forming part of this By-law;
- "Year" means a calendar year.

#### INDEMNITIES:

2. Indomnities are paid to each Member of Council in accordance with Schedule 1.

#### **ENACTMENT:**

3. In accordance with Section 166 of the Tlicho Community Government Act, this bylaw shall be in full force and effect as of the date of adoption of the Tlicho Community Government of Wekweeti this 05 day of August 2005.

- 1.1 Indemnities will be paid as follows:
  - a) All Members of Council and Committee Members will be indemnified at a rate of \$250.00 per meeting for all duly constituted meetings of Council.
  - b) All Indemnities are subject to applicable Revenue Canada Guidelines for elected local officials.
- 1.2 No Member shall be indemnified for a meeting not attended.
- 1.3 Any Member who is asked to leave a meeting under a breach of the Council Procedural Bylaw, Tlicho Community Government Act or Code of Conduct shall not receive any indemnity in respect to that meeting.

### Other Expenses

- 2.1 Members who are on approved travel status will be entitled to receive a Meeting Honorarium of \$300.00 per day.
  - a) Members who are on approved travel status will be entitled to receive a per diem amount as established by the Government of the Northwest Territories published Duty Travel Rates for travel expenses.
- 2.2 Subject to Section 99(3) of the Tlicho Community Government Act, the total yearly amounts of compensation and expenses paid to each member of Council will be included in the financial statements of the corporation.

#### Enactment

- 3.1 Where this bylaw is amended, Public Notice of this bylaw must be posted a minimum of two weeks prior to Third Reading, in accordance to Section 98(2) of the Tlicho Community Government Act. This bylaw shall not be repealed or amended except by an amending by-law.
- 3.2 The Council shall review the Schedule setting the meeting rates periodically.
