Short Term Borrowing By-Law No. 12-2021

A By-Law of the Community Government of Wekweeti in the Northwest Territories pursuant to sections 104 & 105 of the TliCho Community Government Act S.N.W.T. 2018, c13

Whereas the Council for the Community Government of Wekweeti deems it to be necessary or desirable for the Community Government to borrow money for a period of one year or less, on a revolving basis, for the purposes of purchasing material required for the Community Government operations that can only be purchased on line or for other purposes where the Community Government does not have an active account where purchase orders can be used.

And Whereas the borrowing contemplated by this By-Law will not cause the Community Government to exceed any applicable limits for borrowing.

Now, Therefore, The Council of the Community Government of Wekweeti at a duly assembled meeting, enacts as follows:

Short-Term Borrowing

- 1. The Community Government is authorized to borrow up to \$10,000.00 from an approved lender in the form of a Visa/Master Card.
- 2. The term of the borrowing shall not exceed one (1) year.
- 3. The interest rate payable be the Community Government for the borrowing shall not exceed 20% per annum.
- 4. The amounts borrowed pursuant to this By-Law shall be used to meet expenditures that the Community Government is lawfully authorized to incur during the current fiscal year, but cannot be met from current revenues.
- 5. The senior administrative officer shall report to council on the status of the borrowing authorized by this By-Law as part of the financial reports given to council.

Severability

6. Each provision of this By-Law is independent of all other provisions. If a Court of competent jurisdiction declares any provision invalid for any reason, all other provisions of this By-Law shall remain valid and enforceable, and the By=-Law shall be interpreted as such.

By-Law Number 2021-11

A By-Law to repeal section 3(c) of the Water/Sewage Service Standards By-Law. A by-law of the Community Government of Wekweeti in the Northwest Territories to regulate the charge for call out for additional services after hours of regular water and sewage operations as pursuant to the provisions of the Tlicho Community Government Act, R.S.N.W.T., 1988, c. H-1, s.82 and 92.

Whereas, the Community Government of Wekweeti deems it necessary to regulate the additional charge of call out after hours of regular operations for the water supply and sewage disposal pickup as per section 3. (c) of the existing By-Law # 2019-11-16-005

Now, therefore be it resolved that the Community Government of Wekweeti here by amends section 3.(c) to read as follows:

"c. Every customer requesting trucked service at a time other than the normally scheduled service shall be levied a Fifty Dollar (\$50.00) fee payable to the driver before water is delivered or sewage is picked up in addition to the regular charges, except when normal; scheduled services was not available at no fault of the customer."
