Bylaw Number 16-22

Council Honoraria & Indemnity Bylaw

A bylaw for the Tli Cho Community Government of Wekweeti in the Northwest Territories to provide for the payment, to council members, of indemnities, honorariums, and allowances for expenses, pursuant to the TliCho Community Government Act. S.N.W.T. 2004.c.7, s.98

Now, Therefore, The Council of the Community Government of Wekweeti, in a duly assembled meeting, enacts as follows:

<u>Title</u>

1. This bylaw may be cited as the "Council Indemnity Bylaw"

Payments To Chief

- 2. Subject to section 3, the Chief shall receive"
 - (a) The sum of \$500.00 for each council meeting that lasts up to 2 hours, with further compensation of \$175.00 for meetings that last up to 4 hours.
 - (b) The sum of \$200.00 for each committee meeting that lasts up to 2 hours, with further compensation of an additional \$200.00 if the meeting last for the full day.
- 3. The total amount paid to the Chief under section 2 in a given fiscal year of the Community Government shall not exceed a maximum of \$10,000.00.

Payment to Councillors

- 4. Subject to section 5, each councillor, shall receive:
 - (a) The sum of \$500.00 for each council meeting that lasts up to 2 hours, with further compensation of \$175.00 for meeting that last up to 4 hours.
 - (b) The sum of \$200.00 for each committee meeting that lasts up to 2 hours with further compensation of an additional \$200.00 if the meeting lasts for the full day.
- 5. The total amount paid to a councillor, under section 4 shall not exceed a maximum of \$10,000.00

Travel

6. Where a council member is required to travel outside of the Community to conduct business on behalf of the Community Government, and the travel has been approved by council resolution, that council members shall receive, in addition to any amount payable under sections 2 to 5, a further sum of compensation per day of travel, will be compensated at the current Government of NWT duty travel rates set by the Dept. of Human resources and the Treasury Board of Canada.

General

7. In the interest of access to information, the rates and payment amounts set out in this bylaw shall be made available to the public.
